Dear Colleague

The Ministry of New and Renewable Energy, Government of India is pleased to announce that the **3rd edition of Renewable Energy Investors' Meet and Expo (3rd RE-INVEST)** will be held from **14th to 17th October 2020** at Pragati Maidan, New Delhi, India, coinciding with the **Third Assembly of the International Solar Alliance (ISA)**. These two events are likely to be inaugurated by the Hon'ble Prime Minister of India in a common function at 1700 IST on 14 October 2020.

2. The 3rd RE-INVEST is expected to be attended by over 75 International Ministerial delegations, more than 1000 global industry leaders, and 50,000 delegates.
3. The 3rd RE-INVEST aims at accelerating the worldwide effort to scale up development and deployment of renewable energy and connect the global investment community with Indian energy stakeholders.
